Importance of PAN Card

A unique alphanumeric identity which is allotted to each taxpayer is the Permanent Account Number (PAN). It is a 10 digit no. which is provided by the Central Board of Direct Taxes. Presently it is one of the most important documents which acts as financial identity proof for watch of monetary transactions. Whether you have to buy a car or invest in property fill income tax return PAN has become mandatory. It gives a key to track the financial transactions which being above the taxable limits is not eveded by the individuals. Added benefit is that PAN No. remains unaffected even if you change your address throughout the country.

Documents Required for New PAN Application by an individual Indian Citizen (FORM 49A)

Proof of Identity (any one of the following document can be submitted as identity proof)

- Copy of Voter's Identity Card
- Ration card with the applicant's photograph.
- Copy of passport.
- Copy of driving license.
- Arm's license
- Copy of Aadhar Card Issued by Unique Identification Authority of India.

In case of PAN Card application for minors, any of the above documents either for parents or the minor can be submitted as proof of Identity.

Address Proof (any one of the following document can be submitted as Address proof)

- Copy of electricity bills.
- Copy of landline. bills
- Copy of broadband connection bill.
- Bank account statements.
- Credit card statements.
- Passport
- Passport of spouse
- Voter Identity card with photograph.
- Driving license.
- Domicle certificate issued by government.
- Aadhar card issued by Unique identification Authority of India.
- If submitting copy of one of the first five documents, the documents should not be more than three months old.

Proof of Date of Birth (any one of the following document can be submitted as date of birth proof)

• Birth Certificate Issued by the Municipal Authority or any office authorized to issue Birth and Death Certificate by the Registrar of Birth and Deaths or the Indian Consulate.

- Pension Payment order.
- Marriage certificate issued by Registrar of Marriages.
- Matriculation certificate.
- Passport
- Driving License; or
- Domicle certificate Issued by the central or state government
- Affidavit signed before a magistrate Stating the date of birth.

Documents Required for PAN Application by a Foreigner / NRI (FORM-49AA) Proof of Identity (any one of the following document can be submitted as Identity proof)

- Copy of Passport or
- Copy of person of Indian Origin card issued by the Indian Government or

- Copy of other national or citizenship Identification Number or Taxpayer Identification Number duly attested by Apostille or by Indian Embassy or High Commission or Consulate in the Country where the PAN applicant is located.
- Copy of bank account statement in the country of residence.
- Copy of non-resident external bank account statements in India.
- Copy or registration certificate which is issued by Foreigner's Registration Office and shows Indian address
- Copy of Visa granted by the foreign country and / or copy of appointment letter issued by an indian company and original certificate of Indian Address Issued.

Note: The Reserve Bank of India (RBI) has tightened the rules for remitting money abroad under the Liberalised Remittance scheme (LRS) and has made PAN mandatory for anyone using this scheme. Earlier PAN was not insisted upon for transaction up to \$25000. The annual LRS Limit per Individual was raised in 2015 from \$1,25000 to \$2,50000.

CBDT extends PAN Aadhar number linking deadline to 30th September 2019. It is mandatory to quote Aadhaar in ITR u/s 139AA(1)(ii). CBDT Notification 31/2019

SOME RELAXATIONS TO SMALL TAX PAYERS UNDERE GST ACT

Recently, Govt. had provided some relaxations to the small taxpayers in the registration as well as on tax rate applicable on the supplies made by them. These relaxations will come into effect w.e.f. 1st April, 2019.

1. Exemption from obtaining registration (Notification No. 10/2019 (Central Tax):

A person is eligible to avail exemption if he satisfies both the under mentioned conditions:-

- Engaged in exclusive supply of goods
- Aggregate turnover in the FY does not exceed 40 Lakh Rupees

Benefit of exemption is not available if:

- Persons required to take compulsory registration u/s 24
- Persons engaged in making the intra-state supply in the specified states*.
- Persons who had taken voluntary registration
- Persons engaged in making supply of Ice cream & other edible ice, whether or not containing cocoa; Pan masala and Tobacco & manufactured tobacco substitutes.





Liver

The liver is your largest internal organ, weighing about 1.5 kilograms in adults. It sits in the upper, right-hand side of your abdomen, just under your diaphragm (a sheet of muscle that separates your chest from your abdomen). Your liver is divided into 2 main lobes — the right and left lobes — by a membrane called the falciform ligament.

The liver is a dark reddish-brown organ, and holds up to half a litre of blood at any one time. It receives blood from the hepatic artery, as well as from the portal vein. The hepatic artery delivers oxygen-rich blood from the heart, while the portal vein delivers blood that has just left your gastrointestinal tract. Blood reaching the liver via the portal vein is rich in nutrients that need to be processed by the liver.

Functions of the liver

- The liver performs more than 500 functions, including:
- processing nutrients from food;
- storing energy;
- filtering toxic chemicals and bacteria from the body;
- processing alcohol;
- producing certain proteins and fats (including cholesterol), and controlling their metabolism;
- storing iron;
- making certain vitamins, including vitamin A;
- helping with blood clotting; and
- processing medicines.

Bile

The liver also produces bile — a yellow-green fluid that consists of water, bile salts and a chemical called bilirubin. Bile is made in liver cells and travels through a system of channels and ducts in the liver before eventually leaving the liver via the hepatic ducts. Bile is then transported to the gallbladder and the duodenum (the first part of your small intestine) to help with digestion of dietary fats and the removal of certain waste products from the body.

Damage to the liver

The liver is a unique organ because it can lose 80-90 per cent of its cells to disease before it stops functioning, and has the capacity to regenerate itself. However, it is possible for toxins such as alcohol and diseases such as hepatitis or conditions that block the flow of bile to permanently damage the liver. Because the liver has such a large excess capacity, signs and symptoms of disease may not occur until it has been severely damaged.

Signs and symptoms of liver disease

One indication that the liver may be damaged or not working properly is jaundice — a yellow discolouration of your skin and the whites of your eyes, which is caused by a build-up of bilirubin in the body.

Other symptoms of liver disease include persistent itching, fatigue, nausea, loss of appetite and sometimes abdominal swelling or pain. Some forms of liver disease cause dark urine and pale stools.

Testing the liver and its function

A simple blood test, called a liver function test, can be used to assess the basic functioning of the liver. It measures various enzymes and proteins that are produced by the liver, as well as bilirubin, to determine whether the liver is functioning within normal limits.

Other tests commonly used to detect problems with the liver include imaging tests such as magnetic resonance imaging (MRI), CT scan or ultrasound of the liver.

I have given you above most important part of our body Liver and its functions. As people all over world are suffering from liver disorders due to bad dietary habits and intake of alcohol. 





